Management of contractual relationships relating to business activities</li> <li>4. Notice and implementation of campaigns, exhibitions, and other events relating to Products, etc.</li> <li>5. Provision and distribution of catalogs, documents, samples, and other materials relating to Products, etc.</li> <li>6. Business negotiations, meetings, and communications</li> <li>7. Lodging, transportation, meals, and other arrangements in connection with business trips, etc.</li> <li>8. Planning, research and development of Products, etc.</li> <li>9. Personal information regarding job applicants	<ol style="list-style-type: none"> <li>1. Providing information to job applicants (including interns) and communicating the schedule of events and selection procedures</li> <li>2. Selection procedures</li> <li>3. NOK's recruitment management</li> <li>4. Other actions in accordance with the provisions of laws and regulations or with orders and guidance from bodies with legal authority.</li> </ol>
Personal information regarding candidates offered positions, employees, etc.	<ol style="list-style-type: none"> <li>1. Attendance management</li> <li>2. Payment of salaries and operations relating to tax payments, insurance, and employee benefits</li> <li>3. Management of contracts relating to employment</li> <li>4. Operations relating to changes in the status or job of the employee in question, such as recruitment, transfer, leave of absence, change of position, relocation, etc., and the sharing of information with related parties</li> <li>5.
